**LEGISLATIVE PREEMPTION ALERT #1**

**A tax shift is not a tax cut:**

**Vote No on House Committee Bill Proposing to Increase the Homestead Exemption**

**Wednesday, April 5<sup>th</sup>, 2017 - House Ways and Means Committee - 9:00 a.m.**

*Increasing the Homestead Property Tax Exemption*

The **House companion** to [SJR 1774](#) by Senator Tom Lee proposes a constitutional amendment that would increase the homestead exemption by \$25,000, creating a super-exemption of \$75,000 for the first \$100,000 of the value of homestead property. While homestead property owners may appreciate the exemption, it shifts the tax burden to our local business and non-homesteaded property owners.

- **This is a tax SHIFT not a tax CUT.** The tax burden will be placed on local business owners and non-homestead property owners who must choose between more taxes or fewer services.
- **Small counties hit the hardest:** Florida's 29 fiscally constrained counties that are at or near the 10 mill cap will have no choice but to cut the limited services they are barely able to provide today.

- **Citizens will get less with less:** The additional exemption means that counties that choose to maintain their current millage rates must make tough choices about the services provided to their citizens.

#### HOW DO I DETERMINE “MY LOCAL IMPACT?”

Immediately consult with your Property Appraiser and County Administrator/Manager, as well as, finance staff to ascertain the fiscal impact this proposal will cause. Consider likely policy choices that this impact will create: which services are most likely to be cut or eliminated; what would the consequences of any rate increase be?

### **LEGISLATIVE PREEMPTION ALERT #2**

**We can have technology without preemption: Vote no on HB 687**

**Cell phone tower preemption up Thursday!**

**Thursday, April 6<sup>th</sup>, 2017 - House Commerce Committee - 1:30 p.m.**

*Preempting local community control over local taxpayer facilities from private wireless companies*

[HB 687](#) (Rep. La Rosa) will, among other technical provisions, severely limit the ability of local communities to regulate the collocation of small wireless facilities in public rights-of-way. The bill limits the fees (\$15 maximum) counties can charge communication facility companies to locate on taxpayer funded infrastructure.

- **Taxpayers shouldn’t foot the bill:** Both SB 596/HB 687 limit the fees counties can charge the for-profit wireless companies, like AT&T and Verizon, to just \$15 per item on county infrastructure. Wireless companies made billions in profit last year and pay private property owners and even other government entities outside Florida much, much more than just \$15. By limiting what counties can charge these companies for their use of taxpayer-funded and maintained utilities poles amounts to a taxpayer subsidy to private for-profit companies.
- **Let’s work together:** Counties want to bring new and faster technology to their communities but it shouldn’t be on the back of taxpayers. These private for-profit companies need to pay their fair share and defer to public safety experts on where these facilities should go.
- **The Communications Services Tax red herring:** Proponents of this legislation argue that attachment fees should be capped because local governments receive the communications services tax (CST). However, there is no relationship between the CST and the use of county poles. And more importantly the CST is paid by us – the consumers – NOT wireless companies.

- **Protect public safety and community standards:** Local right-of-way regulations are needed to protect the health, safety, and welfare of the public, while maintaining community design standards. Under these bills, counties would be unable to apply basic safety and aesthetic standards to the collocation of small cells.
- **Stop the Preemption:** Both bills limit local communities from *prohibiting, regulating, or charging* for the collocation of these wireless facilities on taxpayer funded infrastructure like traffic signals and light posts.

[HB 17](#) (Rep. Fine) - Relating to local Regulation Preemption

In summary, the legislation proposes to PREEMPT the home rule powers of local governments with regards to the regulation of businesses, professions, and occupations unless it is EXPRESSLY AUTHORIZED by the State. The PREEMPTION is extended to associated regulatory, licenses, and/or permit fees.

[SB 1158](#) (Sen. Passidomo) - Relating to local Regulation Preemption

Although not identical or a companion to [HB 17](#), [SB 1158](#) is very similar in that it proposes to also PREEMPT the home rule powers of local governments with regards to the regulation of commerce, trade and labor. The bill would prevent counties from adopting ordinances that have an adverse impact on commerce, trade or labor, unless it is EXPRESSLY AUTHORIZED by the State.

The PREEMPTION specifically prevents counties from:

- a) Banning the sale of a good or service;
- b) Imposing a penalty on the sale of a good or service;
- c) Requiring an employer to pay any or all of its employees a wage rate not otherwise required under a special, general, or federal law; or extended to associated regulatory, licenses, and/or permit fees.

### **2017 PRIORITIES UPDATE**

#### **OPIOID ABUSE – LISA HURLEY, ESQ.**

[SB 588](#) (Sen. Passidomo) is the companion bill to [HB 249](#) and was amended on 3/27/17 by the Senate Health Policy committee to align itself with the House bill such that it encourages first responders to report certain overdose incident data to the Department of Health within 120 hours of the incident through the existing state Emergency Medical Service Tracking and Reporting System (or other appropriate method) and requires the Department to make the information available to local government agencies no later than 120 hours after receipt. It passed unanimously and has two more committee stops.

[HB 807](#) (Rep. Hager) – related to marketing practices for substance abuse services unanimously passed the House Health and Human Services committee on 3/30/17 and is headed to the floor. Its Senate companion, [SB 788](#) will be heard on either 4/5/17 or 4/6/17 by the Senate Appropriations committee.

[SB 150](#) (Rep. Steube) / [HB 477](#) (Rep. Boyd) creates crimes of trafficking in fentanyl and synthetic drugs and increases penalties for some drug related offenses. This is the priority legislation for the Florida Sheriffs Association. [SB 150](#) will be heard by the Senate Criminal Justice committee on Monday, 4/3/17 at 1:30 p.m. and [HB 477](#) will be heard by the House Justice Appropriations subcommittee on Monday, 4/3/17 at 3:00 p.m.

### **TAX REFORM / LOCAL REVENUE ENHANCEMENT – LAURA YOUMANS, ESQ.**

**House Proposed Tax Cut Package** - The proposed 2017 House tax cut package is intended to provide for a wide range of tax reductions and modifications designed to directly impact both households and businesses, and to improve tax administration. The proposed concepts contain several provisions related to **sales tax** including a reduction of the sales tax on commercial leases from 6% to 4.5% for the first two years and then permanently by 0.5%. For **property tax** purposes, the proposed concepts provide property tax relief for certain property used to provide affordable housing and amends the definition of inventory to include certain construction and agricultural equipment. Based on FAC's analysis of the proposed tax cut concepts, Counties will experience an estimated \$33 million recurring impact statewide. **FAC's initial analysis can viewed here.** [CLICK HERE.](#)

**Communications Services Taxes** - [SB 1636](#) (Sen. Artilles) - Relating to Taxation of Internet Video Service would exclude internet video services from any local tax, charge, fee, or other imposition on related to the provision or purchase of internet video services was passed unanimously in the Senate Communications, Energy, and Public Utilities on 3/28/17.

**10% Assessment Limit on Non-Homestead Property** - [SB 76](#) (Sen. Lee) is scheduled to be heard on Wednesday, 4/5/17 or Thursday, 4/6/17 at 10:00 a.m. in the Senate Appropriations committee meeting.

**Additional Homestead Exemption** - The House companion to [SJR 1774](#) (Sen. Lee) – Increased Homestead Property Tax Exemption – **is scheduled to be heard Wednesday, 4/5/17 by the House Ways and Means committee meeting at 9:00 a.m.** Please refer to **LEGISLATIVE PREEMPTION ALERT #1**

**Local Business Taxes** - [HB 487](#) by Rep. Renner was unanimously passed by the House Ways and Means committee on 3/29/17.

## **COMPREHENSIVE WATER – SUSAN HARBIN, ESQ.**

[HB 285](#) (Rep. Fine) - Relating to Onsite Sewage Treatment and Disposal System Inspections passed 14-1 on March 27, 2017 in the House Natural Resources and Public Lands Subcommittee. The bill has been amended significantly to remove the point of sale inspection requirement. In its current form, [HB 285](#) would require DOH to create a database of existing septic systems including location and operational condition. The amended bill also requires a disclosure form at the point of sale (offered by the seller and acknowledged in writing by the purchaser) indicating that a septic system exists on the property.

[SB 1438](#) (Sen. Broxson)– Relating to Aquifer Replenishment passed unanimously on Tuesday, March 28, 2017 in the Senate Environmental Preservation and Conservation committee.

[SB 532](#) (Sen. Galvano) related to public notices of pollution will be heard on 4/6/17 by the Senate Appropriations committee at 8:00 a.m.

[SB 10](#) (Sen. Bradley)– Relating to Water Resources will be heard by the Senate Appropriations committee on Wednesday 4/5/17 at a time certain of 2:00 p.m.

## **2017 EMERGING ISSUES UPDATE**

### Health & Human Services / Public Safety

[SB 1068](#) (Sen. Brandes) / [HB 157](#) (Rep. Burgess) - Relating to Sentencing:

[SB 1068](#) (Sen. Brandes) was substantially amended on 3-27-17 in the Senate Criminal Justice committee to include the substance of [SB 1194](#) (Sen. Bracy) which includes sentencing guidelines and criteria in upward and downward departure sentences which is designed to bring more uniformity to sentencing. It has two more committee stops; its House companion [HB 157](#) has two more committee references.

[HB 7051](#) (Rep. Byrd) - Relating to Clerks of the Circuit Court

This bill revises the way in which clerk of court budgets would be approved. Specifically, it removes the duties of LBC regarding budgets of Florida Clerks of Court Operations Corporation & clerks of court; revises duties of the corporation; revises budgeting requirements for court-related costs of clerks of court; requires cost of certain changes in court rules & administrative orders to be reviewed by Criminal Justice Estimating Conference; revises duties of JAC relating to budgets & payroll of clerks of court.

The Clerks do not support in its present form mainly because their budgets could never be higher than the REC estimate and provides not mechanism for midyear adjustments. The Clerks estimate this would result in an additional minimum \$14 million cut to their budget. **It passed out of the Justice Appropriations subcommittee on 3-27-17 by a 7-5 vote.** It has one more committee stop. Meanwhile the Senate filed [PCB 2506](#) this week which provides for additional funds for clerks and a mechanism to adjust for budget fluctuations during the year, which is supported by the Clerks.

#### Finance, Tax & Administration

**House and Senate Budget:** The Senate and House proposed budgets for State Fiscal Year (SFY) 2018 total approximately \$83.2 billion and \$81.2 billion respectively and differ by approximately \$2 billion. Health and Human Services received the largest portion of funding in both proposed budgets, ranging from \$35.51 billion in the Senate to \$34.06 billion in the House. Proposed general revenue expenditures for SFY 2018 range from approximately \$31.57 billion in the Senate to \$30.19 billion in the House.

#### **County funding highlights include, but are not limited to:**

1. Both chambers have increased funding for **Community Mental Health Services** compared to the current year, with the House recommending \$458,008,017 and the Senate recommending \$468,259,690.

2. **Delinquency Prevention Program:** The Senate proposed total of \$87,349,839.00 in funding and the House's proposed a lessor amount of \$74,066,962.00. Specifically, The House recommended \$16,819,808 for funding for PACE Center for girls, which the Senate recommends \$20,619,808.00.
3. The Senate has offered \$50 million for **springs restoration**, while the House recommends \$40 million, both using the Land Acquisition Trust Fund (LATF).
4. The Senate has included funding equal to \$124 million for **S.H.I.P**, However, the House has only included funding equal to \$34 million.
5. The House has included funding equal to \$24,449,440 for **libraries**. The Senate proposes \$33,202,391.
