



**Interim Committee Week: County Lobbyist Call
Monday, February 11, 2019**

Welcome & Opening Remarks

Davin Suggs, FAC's Director of Public Policy, gave the following updates:

- FAC Legislative Days are March 27-28, 2019, in Tallahassee. Please [click here](#) for more information and to register. The legislative briefing will occur on Wednesday, March 27th and the FAC Water Policy Committee will have its first meeting on Thursday, March 28th.

PRIORITIES

- **SB 594 (Hutson) State Shared Revenues** continues to remain a priority of FAC's during committee weeks. The bill requires the Attorney General, at the request of one or more members of the Legislature, to investigate whether a certain official action of the governing body of a county or municipality violated state law or the State Constitution; requiring the Attorney General to report his or her findings and conclusions to the Governor, the Legislature, and the Secretary of State; providing requirements if no violation is found, etc.

FAC staff has met with the bill sponsor, Senator Hutson, but FAC opposes the bill. There is no House companion at this time.

- **HB 3 (M. Grant) Preemption of Local Regulations** is a priority bill for FAC. The bill prohibits local governments from imposing or adopting new regulations on businesses & business entities on or after specified date; specifies certain regulations expire & may only be readopted or continue to be imposed after meeting specified criteria; preempts regulation & licensing of professions & occupations to state; prohibits local governments from imposing additional regulations unless specified conditions are met; specifies that local regulations that do not meet specified criteria do not apply; specifies certain specialty contractors are not required to register with Construction Industry Licensing Board; prohibits local governments from requiring certain specialty contractors to obtain license; specifies job scopes for which local jurisdiction may not require license.

FAC staff has a meeting with the bill sponsor, Rep. Michael Grant, this week. FAC opposes the bill. There is not a Senate companion at this time.

WATCHING CLOSELY

- **HB 693 (Fischer) Communications Services.** This bill reduces communications services tax rate on sales of communications services; revises authority for municipalities, and counties to impose permit fees on providers of communications services that use or occupy municipal or county roads or rights-of-way; deletes procedures, requirements, & limitations with respect to such fees.
- **SB 204 (Brandes) Detention Facilities.** The bill requires that a custodial interrogation at a place of detention be electronically recorded in its entirety in connection with certain offenses; requiring law enforcement officers who do not comply with the electronic recording requirement or who conduct custodial interrogations at a place other than a place of detention to prepare a specified report; prohibiting introduction into or possession of any cellular telephone or other portable communication device on the grounds of any county detention facility, etc.
- **SB 332 (Pizzo) Incarcerated Women.** Citing this act as the "Dignity for Incarcerated Women Act"; requiring correctional facilities to provide incarcerated women with certain health care products, subject to certain requirements; providing requirements for male correctional facility employees in certain circumstances; requiring documentation of certain incidents involving male correctional facility employees, etc.
- **SB 302 (Brandes) Nonemergency Medical Transportation Services.** Authorizing Medicaid nonemergency transportation services to be provided to a Medicaid recipient by certain transportation network companies or transportation brokers, subject to compliance with certain requirements; requiring the Agency for Health Care Administration to update the Non-Emergency Transportation Services Coverage Policy by a specified date, etc.
- **HB 127 (Williamson) Permit Fees.** The bill requires governing bodies of counties & municipalities to post their permit & inspection fee schedules & building permit & inspection utilization reports on their websites; requires governing bodies of local governments to post their building permit & inspection utilization reports on their websites by specified date; provides requirements for such governing bodies; provides reporting requirements.
